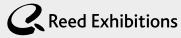

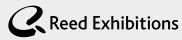
Signature, Maturity, GENERAL eligibility requirements

1. The Organiser of the Global Drinks Forum (Event) is Bar Convent GmbH, Völklinger Straße 4, 40219 Düsseldorf, Germany.
2. These Conditions of Participation apply for contracts between the Organiser and Participants in the Global Drinks Forum (Participants). Deviating conditions of business of the Participant do not apply.
3. The application by the Participant for the Event presupposes the use of the application form of the Organiser for the Event. The application form must be fully completed by the Participant and must be signed with a legally binding signature. Conditions or provisos by the Participant on the application form will not be taken into account.
4. The application is presumed to have been accepted where it has not been rejected by the Organiser within 14 days of receipt of the application by the Organiser. Irrespective of this, the Participant receives a booking confirmation from the Organiser.
5. The participation fee becomes due for payment without deduction, 14 days after the Participant has received the invoice.
6. A transfer of the participation in the Event is not possible. Similarly, the transfer of rights and obligations from the contract by the Participant to a third party, in particular to some other Participant, is excluded.
7. The Participant is entitled to withdraw from the contract by giving a written declaration to the Organiser up to three months before the start of the Event. In this case, the Participant is obliged to pay to the Organiser a cancellation fee amounting to 50 % of the agreed fees to the Organiser. A withdrawal by the Participant from the contract is otherwise excluded.
8. The Organiser is entitled to cancel the Event. In this case, the Organiser immediately refunds the Participant with the participation fee paid by the Participant. All other claims by the Participant are excluded, except in cases of deliberate or gross negligent behaviour by the legal representatives, employees or other vicarious agents of the Organiser.
9. The Organiser is liable for deliberate or gross negligence. In the Event of a merely negligent breach of duty by the Organiser or its vicarious agents, the liability is however limited to the contract typical, foreseeable loss. There is absolutely no liability towards companies in the Event of a merely negligent breach of insignificant contractual obligations. The aforementioned limitations on liability do not apply for the Organiser in the Event of attributable bodily injury or damage to health or loss of life.
10. The law of the Federal Republic of Germany, excluding the UN Convention for the Sale of Goods, applies exclusively to the contractual relationship as well as to these Conditions of Participation.
11. No ancillary verbal agreements have been made to the contractual relationship nor to these Conditions of Participation. Changes and supplements to the contractual relationship or to these Conditions of Participation require the written form. This also applies for an alteration, supplement or revocation of this written form clause.
12. If one of the regulations of these conditions of contract or of these Conditions of Participation shall be or become void, this shall not affect the validity of the other regulations. In this case, an effective regulation that comes closest to the intention and purpose of the void regulation shall apply. For the contractual relationship and the Conditions of Participation, the German version shall apply exclusively.
